**SCOPE:**

Periodical inspection and testing of transportable refillable gas cylinders performed according to the following standard (listed under pt. 6.2.4.2 of ADR 2017):

**EN ISO 10462: Periodic inspection and maintenance of dissolved acetylene cylinders**

**The scope of the certification is only valid for the following dissolved acetylene gas cylinders:**

- # Cylinders made according to 'TPED' Directives 99/36/EC or 2010/35/EU ('π' Cylinders).
- # Existing transportable refillable acetylene gas cylinders made **from 01/01/1978**, according to the Belgian regulation "ARAB" (Algemeen Reglement voor de Arbeidsbescherming) and ADR, initially controlled by Apragaz, wearing the both following characteristic stamping:
  - For the empty cylinder: The letter "E", the date (month and year), our stamp: (B).
  - For the porous mass: The name of the porous mass preceded or followed by our stamp: (B).

- # Acetylene Cylinders which have been re-assessed by an approved Notified Body or an EU competent authority (*Certificate of Type Reassessment must be available on site; (See TPED 2010/35/EU, Annex III (5)).*)
